## **I. Study programme**

For the academic year 2025/2026 admission to the Faculty of Environment of the J. E. Purkyně University in Ústí nad Labem and the Institute for Global Change Research Institute CAS v.v.i. (CzechGlobe) in Brno:

1. in the doctoral study programme **Landscape reclamation and ecosystem services**, form of full-time study, place of study Ústí nad Labem and Brno.

## **II. Numbers of admitted students**

With regard to the capacity of the faculty, admission to the first year of study in the academic year 2025/2026 is expected in the study programme:

**Landscape reclamation and ecosystem services**  
maximum 1 student - full-time study, place of study Ústí nad Labem,  
maximum 1 student - full-time study, place of study Brno.

In justified cases, the dean may increase the number of admitted students.

## **IV. Prerequisites for admission to study**

### **1. Application deadline**

**October 31, 2025**

### **2. Method of delivery**

The faculty accepts **only electronic applications** entered in the STAG system and subsequently printed and sent by post to the faculty's address by the deadline:

or directly to the faculty's mailroom in Ústí nad Labem. The deadline is adhered to if the consignment containing the written application was delivered to the faculty's study department no later than **October 31, 2025**.

### 3. Electronic application form

including detailed instructions for completion is available on the UJEP website at <https://portal.ujep.cz/portal/studium/uchazec/eprihlaska.html>.

The completed electronic application form **must be printed out, the prescribed annexes attached, signed and sent by post** to the address given in point 2. or handed in directly at the faculty's office. If the application is not received in writing with the prescribed particulars by the deadline laid down in point 1, the admission procedure will not be initiated.

### 4. Prescribed annexes to the application form

a) A graduate of a master's or further master's degree (hereinafter referred to as "master's") must attach to the application a **certified copy of the diploma with a Diploma Supplement or a certificate of the state final examination (SFE)**.

Officially certified copies of the above prescribed annexes **may be replaced by an authorised conversion of documents from paper to electronic form in PDF format with a conversion clause** (e.g. from a contact point of a public administration offering the Czech POINT service) **in the form of annexes to the e-application**.

Applicants who have not yet completed their Master's studies at the time of application must submit the above-mentioned attachments **no later than the day of the entrance examination**.

A candidate for study at UJEP who has applied for study in a doctoral study programme and has a foreign higher education degree is obliged to prove in the admission procedure the achievement of the required level of higher education by means of the document referred to in Section 48(5)(a) to (c) of the Higher Education Act, in the manner specified on the website <https://www.ujep.cz/en/recognition-of-foreign-education>.

b) Each applicant must demonstrate his/her interest in studying the programme in the form of a **Cover Letter** in English, signed and attached to the application form.

c) A **Structured Personal CV** in English is also a mandatory annex.

d) The applicant is also obliged to fill in and send together with the application form the **"Application Supplement for the Doctoral Programme"**, which is published on the Faculty's website in the Ph.D. study section at <https://www.fzp.ujep.cz/en/phd-study>.

The annexes referred to in points b), c) and d) can be submitted **electronically in PDF format as annexes to the e-application**.

Failure to deliver the prescribed application annexes properly and on time is considered a failure to meet one of the necessary conditions for admission to study at the Faculty.

1. There is no admission fee designated.

## **VI. Additional information about the admission procedure**

**1. Confirmed medical certificate of eligibility for higher education is not required.** During the study of all accredited study programmes, work with chemical substances in laboratories, and movement in the open field and in industrial facilities is expected.

**2. Applicants with specific educational needs** are advised to contact the University Support Centre for Students with Specific Needs (UCP UJEP) before submitting their application. The University Support Centre for Students with Specific Needs will provide applicants with individual consultations on the possible form and type of study and discuss with them possible modifications to the admission procedure according to the type of disability and on the basis of the relevant legislation. When applying to study, it is necessary to indicate the requirement to take into account specific health conditions - visual, hearing or physical impairment, chronic illness, mental illness and specific learning disabilities. In the electronic application, you just need to tick the appropriate box. On the basis of this statement, the applicant will be contacted by staff from the University Support Centre for Students with Special Needs to arrange a personal meeting and discuss the necessary requirements.

**3. Enrolment of candidates admitted to study will take place in December 2025.** The exact date will be specified in the invitation to enrol in the studio. Failure to appear for enrolment is regarded as a resignation from the programme to which the student has been admitted. According to the internal regulations of the University, the personal presence of the applicant or his/her representative with a certified power of attorney authorizing administrative actions is required for enrolment.

## **VII. Determination of the ranking of candidates**

1. Graduates of a Master's degree programme in Landscape Reclamation, Ecosystem services, Environmental Protection, Ecology or a related programme may be admitted to the Landscape Reclamation and Ecosystem Services PhD programme. The entrance exam will be oral and conducted in English. The test consists of three parts:

- a) orientation in the broad field of environmental protection ranging from ecology, climatology, agronomy, forestry or nature conservation knowledge of legislation to economic factors in relation to the topic of the future thesis,
- b) English language skills (the ability to understand professional text and to communicate in basic English is tested),
- c) professional debate (the candidate will present a proposal of the topic of his/her dissertation and the general concept of the solution, or he/she will also present his/her previous professional activities).

The ranking of applicants will be determined on the basis of the total number of points obtained in the entrance examination. In each section, the candidate may obtain the following number of points:

- environmental protection exam: 0 to 20 points,
- foreign language exam: 0 to 10 points,
- expert debate: 0 to 40 points.

- 2. To pass the admission test, the candidate must achieve at least 50 % in each of parts (a) to (c) in point 1.
- 3. An absolute ranking of the applicants will be compiled from all the applicants based on their results. The ranking of the best candidates and the maximum number of accepted candidates are decisive.
- 4. The deadline for the processing of applications for doctoral studies and verification of compliance with the admission requirements is November 30, 2025. After this deadline, the result of the admission procedure will be published on the UJEP website within 2 weeks.
- 5. The faculty will send out written decisions on the outcome of the admission procedure within 15 days of the deadline set for verifying compliance with the admission requirements. Applicants who have been accepted for study will receive an invitation to enrol at the same time.
- 6. The Dean of the Faculty reserves the right, according to the development of the number of applicants
  - a) extend the deadline for the submission of applications for studies,
  - b) announce additional rounds of the admission procedure.
